Red Line Rehab Begins Along the Dan Ryan **Expressway**

n March 24, 2004, Chicago Mayor Richard M. Daley, CTA Frank Kruesi and other community officials announced the beginning of CTA's \$282.6 million Red Lines rehabilitation project. The work, which is now underway, involves upgrading track electrical power and renovating seven stations. When the project is completed in the fall of 2006, customers will experience more reliable and efficient rail service and upgraded stations.

Improving power reliability and the delivery of that power are the most significant aspects of the project. Since the Dan Ryan branch of the Red Line opened in 1969, the CTA has added trains and increased their frequency to keep up with customer demand. In fact, the branch today transports nearly four times more people annually than it did the first year it operated. In 1969, rail cars did not require as much power to operate as today's more modern rail cars. The Red Line ran six-car trains with rush hour intervals at five to seven minutes. Today, the Red Line runs eight-car trains with rush hour intervals at three to five minutes.

Here is a summary of the construction schedule:

Phase I (March 2004 – March 2005)

Construction during this phase includes the replacement of third rail track and other special track. It is necessary for trains to operate periodically on temporary (bypass) tracks on the left shoulders of the Dan Ryan Expressway in both directions at specific work zones between Cermak Avenue and 95th Street. A total of eight sets of by-pass tracks will be built over the course of the project. Trains travel within corridors located between CTA's existing concrete barrier and a new temporary concrete barrier. This allows the CTA to continue running normal rail service during construction. Boarding procedures for CTA customers remain the same.

The location of the temporary tracks requires Dan Ryan expressway traffic to shift one lane to the right (both southbound and northbound). To prepare for the lane shifts, the CTA has been smoothing



shoulders of the expressway to be used as driving lanes. Four lanes of traffic in both directions will be maintained.

For safety reasons, select entrance ramps will be closed temporarily while lane shifts are underway, with no more than two ramps closed at any one time. Each ramp will close for approximately eight to ten weeks. The northbound 87th Street entrance ramp is temporarily closed until early May. The northbound 71st Street entrance ramp is temporarily closed until mid-June. Other temporary ramp closures will be, in order, northbound 95th Street ramp, northbound 79th Street ramp and southbound 76th Street ramp.

The CTA is working closely with the Illinois Department of Transportation (IDOT) to minimize the impact of construction on community residents and other motorists who use the Dan Ryan Expressway.

 Phase II (August 2004 – January 2006) The work during this phase will involve the construction of two new power substations and upgrades to two other substations and the installation of new contact rail, which will result in increased power for the branch.

Phase III (August 2005 – Fall 2006)

Seven stations from Sox/35th to 87th Street will receive upgrades including new flooring, enhanced lighting, new platform canopies, new escalators, improved signs and elevator installation at two locations (47th Street and 69th Street stations), making the stations newly accessible to customers with disabilities.

The Red Line rehab project, along with the ongoing rehabilitation of the Cermak branch of the Blue Line and the upcoming Brown Line capacity expansion project, are tangible proof of the CTA's commitment to improve our product and invest in the communities we serve.

Kedzie Station Reopens Along Cermak (Douglas) Blue Linesm

On Monday, March 29, the Kedzie station & reopened for customer use. The state-of-the-art, accessible station located at 1944 S. Kedzie, in the North Lawndale neighborhood, is the fifth out of eight stations to be rebuilt through the CTA's \$483 million renovation of the Cermak (Douglas) branch of the Blue Line.

The Kedzie station offers a number of customer-friendly amenities including two entrances. The main entrance to the stationhouse is on the west side of Kedzie, with an auxiliary entrance and exit located on the east side of Kedzie, providing convenient access to the station.

For customer comfort, the new center platform features benches, overhead heaters and enhanced lighting. Canopies have been installed to protect customers from the elements. Station signs and a public address system help customers navigate the station and receive travel information.

With a newly installed elevator, escalator, wheelchair turnstile, TTY telephones, tactile edging and Braille signs, the Kedzie station becomes the eighth station on the Cermak (Douglas) branch to be accessible to customers with disabilities.

In addition to the new customer amenities, CTA also integrated historical features. The front of the original stationhouse was restored and incorporated into the new stationhouse and a portion of the historic canopy hangs over the east end of the platform.

CTA Encourages Customers to Just Rack and Ride

Service Improvements on 11 Bus Routes

The following bus service improvements went into effect Sunday, April 25 or Monday, April 26, 2004. The changes benefit customers by providing additional transit options, more direct and convenient service and reduced travel times.

New Routes

#148 Clarendon/Michigan Express & — **Effective April 26**

This new route serves customers who want to enter Lake Shore Drive at Irving Park, replacing service most recently provided by the #145 Wilson/Michigan Express route. Buses operate in the peak direction of travel during morning and afternoon rush periods. Trips operate in the morning (5:50 a.m. to 9:00 a.m.) between Wilson/Ravenswood and Michigan/ Congress and in the afternoon (3:00 p.m. to 6:30 p.m.) between State/Congress and Wilson/Ravenswood.

Route Improvements

#N4 Cottage Grove & — Effective April 25 Buses are being rerouted to add overnight owl service through the Illinois Center complex and a new southbound stop at Michigan/Randolph, which also serves #151 Sheridan & and #N66 Chicago & buses. The addition of the #N4 & stops provides a convenient transfer point for customers on those routes looking to complete their trips to the South Side.

#18 16th/18th & - Effective April 25

The eastbound extension of the route to connect with the Cermak-Chinatown station on the Red Line was made permanent. The extension was initially introduced in December 2002 as a service experiment. Increased ridership contributed to the route becoming permanent.

#37 Sedgwick/Ogden & - Effective April 26 Southbound buses now terminate their route at the newly-renovated Pulaski & station on the 54th/Cermak branch of the Blue Line. The new bus turnaround provides a direct connection to the Blue Line.

#72 North & — Effective April 26

Every bus, instead of every other bus, now operates west of Narragansett to/from Harlem

from 10:00 a.m. to 2:00 p.m. every ten minutes on weekdays. Service west of Narragansett to Harlem runs later on weekday evenings. The last bus leaves Harlem at 12:06 a.m. instead of 10:50 p.m. allowing for improved connections with Pace and area employers.

#96 Lunt & - Effective April 26

Buses now operate to a new west terminal at Devon/Kedzie, instead of the Skokie Industrial Park. This change provides direct service for shoppers and employees of Lincolnwood Town Center.

#152 Addison & - Effective April 26

Buses now operate one half-hour later on weekday evenings. The last eastbound bus from Cumberland leaves at 9:40 p.m. instead of 9:10 p.m., and the last westbound bus from Lake Shore Drive leaves at 10:30 p.m. instead of 10:00 p.m.

#156 LaSalle — Effective April 26

Buses now operate 35 minutes later on weekday evenings. The last southbound bus leaves Belmont/Halsted at 7:30 p.m. instead of 6:55 p.m. and the last northbound bus leaves Desplaines/Harrison at 8:05 p.m. instead of 7:30 p.m.

#201 Central/Ridge & — Effective April 26

In order to provide service closer to the Northwestern University campus, buses now operate via Sheridan instead of Sherman.

Route Changes

#X21 Cermak Express & — Effective April 25

Buses return to their pre-experimental routing and schedule. Low ridership to the Medical District and downtown was the key factor in this change. Service now operates Saturdays, Sundays and holidays from 7:40 a.m. to 7:40

#145 Wilson/Michigan Express — **Effective April 25**

Buses revert back to the pre-experimental routing. Based on customer feedback and staff observation, this change will help alleviate crowding on the #146 Inner Drive/Michigan Express. Southbound #145 Wilson/Michigan buses enter and exit Lake Shore Drive at Belmont.
