Earned Income Tax Credit

The tax time is fast approaching. You or someone you know could be eligible for a tax refund with the federal Earned Income Tax Credit (EITC). If you are eligible, the EITC can help lower the amount of federal taxes you owe. The EITC can even help eligible families receive a refund based on their federal tax withholdings for the year.

You may qualify, if you:

Possible Refund

have two or more children* and earn up to \$35,458.	\$4,300
■ have one child* and earn up to \$31,338.	\$2,604
are between the ages 25 and 64, have no children and earn up to \$12,490.	\$390

* A qualifying child includes a natural, adopted, stepchild, grand child, great-grandchild or eligible foster child, children under age 19 or under age 24 and a full-time student, or; children at any age, if permanently/totally disabled (that is, if he or she receives Supplemental Security Income or Social Security Disability)

Even if you don't owe income tax, you may be entitled to get the credit and cash! Last year's average EITC refund was \$1,920. In addition to the federal EITC, the State of Illinois has a state EITC that provides additional income tax relief. Essentially, the Illinois EITC boosts the taxable income threshold.

Families and individuals with incomes less than \$36,000 are eligible for free confidential tax preparation assistance by professionally trained volunteers. The Tax Counseling Project and the Tax Assistance Program, both Chicago-area non-profit programs, offer the assistance at 31 sites in Chicago and 21 sites outside the city. Residents should bring all current W2 and 1099 forms, Social Security cards for all household members, a copy of the filers 2003 tax return, and photo identification.

CTA Bus Routes to Become 100 Percent Accessible

The Chicago Transit Board recently approved the purchase of 13 accessible buses that will enable the CTA to make 100 percent of its 150 bus routes fully accessible to people with disabilities. The buses will be used on CTA bus routes #170, #171, #172 and #173 that serve the University of Chicago campus in Hyde Park. These are the only CTA routes currently not accessible.

Historic Wilson Station Rehabiliation Moves Forward

A contract has been approved for the design of the Red Line's Wilson station and station house. The project is expected to introduce modern amenities while preserving the station's historic architectural features. The station was originally constructed in 1900 and is listed as a contributing structure in the Uptown Square Historic District on the National Register of Historic Places. Design work is expected to be completed by the end of 2006.

Bus Route Changes

With the restoration of weekend service on the newly renovated 54th/Cermak branch of the Blue Line in January, the Chicago Transit Board approved the following changes to the #X21 Cermak Express & and the #21 Cermak & bus routes.

#X21 Cermak Express &—effective January 30, 2005

CTA created the limited stop route in December 1998 to provide weekend transit service in lieu of Blue Line rail service. Since the addition of weekend rail service on the 54th/Cermak branch of the Blue Line on January 1, the Board approved the elimination of the duplicate service provided by the X21.

#21 Cermak &—effective January 30, 2005

The board also approved a 180-day experiment on the #21 Cermak & bus route which incorporates trips to North Riverside Park Mall—one of the most popular aspects of the former #X21 Cermak & bus route. Under the experiment, the #21 Cermak & bus route extends its run and terminates at the North Riverside Park Mall instead of the rail terminal at 54th/Cermak. Buses operate to the mall approximately every 20 minutes from 8 a.m. until 10:30 p.m. on Saturdays and from 9 a.m. until 8 p.m. on Sundays and holidays. Eastbound trips continue to terminate at McCormick Place.
