

## F.C. Knautz Named **CTA's Director of Public Information**

APPOINTMENT OF Francis C. Knautz, who began his transit career with the former Chicago Surface Lines in 1942, as Director of Public Information for the Chicago Transit Authority, effective October 1, has been announced by Chairman George L. DeMent of Chicago Transit Board.

Mr. Knautz succeeds H. L. Polland, who retired October 1 from the post he had held since the inception of CTA in 1945.

A native Chicagoan, Mr. Knautz started with the Chicago Surface Lines organization on August 7, 1942, in a clerical capacity in the Transportation Department. In 1945 he served as a traffic supervisor and later that year became confidential clerk to the superintendent of transportation. On June 15, 1951, he was named public information assistant in Mr. Polland's office, and on September 27, 1954, was appointed assistant superintendent of job classification, advancing to the superintendent's post on December 1, 1957. On February 1 of this year he was named superintendent of employe relations, the position he held at the time of his new appointment. He also has served as executive secretary of CTA Employes Suggestion Plan Committee since June 11, 1962.

A graduate of Austin High school, Chicago, in the class of 1932, he attended Northwestern university where he studied business administration. He later took management courses at both the University of Wisconsin and Marquette university.

Mr. Knautz has been active in church, fraternal and community organizations for many years.

He attends Redeemer Lutheran church, 900 N. Lockwood avenue, and has been a member of the church council for fourteen years. He also is a board member of the Lutheran Student Foundation of Northern Illinois university, and on October 17



### First New Tuition Refund Checks Presented



THE FIRST two employes to receive financial aid toward their education under CTA's new tuition refund plan were presented with checks recently, reimbursing them for successfully completing courses approved by the plan.

Michael G. Kelly and Walter D. Moore Jr., both apprentice testing technicians in the Electrical Department, qualified by attending summer courses in physics at Illinois Institute of Technology. They Thus the tuition refund plan, announced last June, has proven its effectiveness and it is hoped that many other employes who can qualify will take advantage of this opportunity to help them better their education.

It is pointed out that applications for a tuition refund are relatively simple. The requirements are: (1) that the applicant is a full time employe with three or more months of service at the time he begins course; (2) that the selected course or courses are related to the employe's CTA job; (3) that the employe must receive a satisfactory grade in the course or courses in which they are enrolled, and (4) that he must be actively employed by CTA at the end of the course.

Employes interested in taking advantage of the tuition aid plan should contact their supervisors for further details of the plan and for application blanks.

Frank A. Johnson, supervisory training coordinator, Training and Accident Prevention, is responsible for administration of the plan.






CTA'S "Handy-Holder" for Rapid Transit Riders TO SPEED-UP transfer validating at rapid transit stations, a new time-saving device, called the "Handy-Holder," is being distributed by CTA's Public Information Department.

The cardboard folder holds the transfer in the validating machines and provides a stiff backing for time-stamping transfers. All transfers must be time-stamped when changing from the rapid transit trains to buses.

The idea for the "Handy Holder" was conceived by Alexander Dunn, a retired Chicago business executive, who submitted it for consideration by CTA officials. Mr. Dunn had conducted a series of experiments in its use at various busy transfer stations with good public acceptance. Since being made available by CTA there has been a considerable public demand.

The "Handy Holder" may be obtained without charge from agents at rapid transit stations or from the CTA Public Information Department, P.O. Box 3555, Chicago 60654, or by phoning MOhawk 4-7200, Extension 805.

### New Routings Established for Expressway Runs

A NEW routing for CTA's Vincennes-111th and Garfield express service utilizing the Franklin street connector between the Dan Ryan expressway and Cermak road was approved at the October 1 meeting of Chicago Transit Board. The change in routing will go into effect October 26.

With the opening of the Franklin street connector, a more direct route into the Central Business District is made possible for the express buses operating via the Dan Ryan expressway in the a.m. and p.m. rush periods for both the Vincennes-111th and Garfield routes.

This additional one mile of expressway travel will mean a time-saving of about three to four minutes for CTA riders.

Northbound buses of the Vincennes-111th route will continue in the Dan Ryan expressway to the Franklin street connector, north in the Franklin street connector to Cermak road, east in Cermak to Clark street, and then continue over the regular route. Southbound buses will follow the same routing in reverse.

Northbound Garfield buses will operate over the existing route to 35th street and then continue in the Dan Ryan expressway to the Franklin street connector, north in the Franklin street connector to Cermak road, east in Cermak road to Wabash avenue, and then north in Wabash over the regular route. Southbound buses will continue over their present routing to Michigan and Cermak and then follow the above route in reverse.

In another Board action, operation of certain Archer Express buses via the Southwest expressway during the a.m. and p.m. rush periods on weekdays was authorized. This change also will become effective, October 26.

About half of the Archer Express buses originating at or destined for Archer-Harlem will be operated over a five-mile stretch of the Southwest expressway between Pulaski road and the Canalport exit near 18th and Canal street. About eight minutes will be saved via the expressway route.

### **Baxa Named to New Public Information Post**

APPOINTMENT OF C. William Baxa as assistant director of public information for the Chicago Transit Authority was announced effective October 4 by Thomas B. O'Connor, CTA general manager.

Mr. Baxa, a former news writer and publications' coordinator, respectively, in the Public Information Department joined CTA on June 23, 1958, following editorial work in various fields.

A graduate of St. Mary's college, Winona, Minnesota, where he received a B.A. degree in 1951, he served with the U.S. Army from March, 1945, to December, 1946, and for part of that time was stationed in Japan. He was a teacher at St. Mel High school in Chicago in 1952 and 1953.

Mr. Baxa, who was born in Chicago on December 30, 1926, resides with his wife and one-month old daughter at 1035 Bellwood avenue, Bellwood, He is a member of Divine Infant church in Westchester, where he is active in the Holy Name Fathers Club, Variety Club and Men's Glee Club.



### TWO CTA EMPLOYES HAILED AS HEROES

A CTA electrical worker played a leading role in apprehending a holdup man who earlier had robbed a subway ticket agent on the near north side recently.

Electrician Sam Cole became aware of the situation when he saw a man dash from the subway ticket booth at Lake street transfer station of the Dearborn subway after the agent, Mary Morgan, had screamed. Cole followed the man to street level, then chased him west on Lake street and on other downtown streets and alleys.

When Cole saw the pursued man board a bus on Wells street near the Merchandise Mart, he hailed a nearby squad car and the bus was curbed two blocks north on Wells. The man, however, got off the bus and raced into an alley before Cole and the police officer could take him into custody. He was finally cornered in a warehouse at 610 N. LaSalle street.

By calling out he would shoot, Cole drew the man out of a vault in which he was hiding. Cole had no gun, but he handled the situation by slugging the man with his fist and the man surrendered.

Near the warehouse the police found a length of pipe that he apparently had been using as a makebelieve shotgun.

He was later identified by Patricia Boland, agent at Chicago-Milwaukee station, who earlier in the day had robbed her at knife-point and taken \$13.66 in cash.

Cole once before bested a holdup man when he was a CTA bus operator. Confronted by a stickup man who tried to take his coin changer, Cole fought him off by hitting him on the head with his transfer punch. Cole started with the Transportation Department in 1954, and transferred to the Electrical Department in 1961. CREDITED WITH saving the lives of three children he rescued from a fire that claimed the life of their sister, Operator Joseph E. Lewis, badge No. 911, 77th, was hailed as a hero in press, radio and TV reports of his action.

Driving a No. 3 southbound bus on South Parkway on September 10, Lewis saw flames leaping from a frame house at 7317 South Parkway. Curbing his bus, he ran into the front hallway, where he saw three children staring with fright at the flames in the kitchen of the house.

He picked up the two smallest children and led the third one by the hand out of the flaming structure.

Occupants of the house are Mr. and Mrs. Clarence Stewart. The body of their three-year old daughter, Crystal, was found in the attic after the flames were extinguished.

The children saved by Lewis were Ruth, 8, Samuel, 4, and David, 2. Mr. Stewart was not home when the fire broke out, but his wife, Lois, helped their two oldest children, Monica, 12, and Angela, 10, get out of the house. The Stewart's seventh child, Paul, 7, was rescued from the roof of the house by firemen.

Lewis continued on his route after rescuing the children. He tried to fight the fire with a garden hose until firemen arrived.

A CTA bus operator for four years, Lewis was presented a Chicago Medal of Merit by Mayor Richard J. Daley in his office on September 14. It is the City's greatestaward for individual bravery. He also received a "Citizen Salute" certificate from radio station WBEE in recognition of his heroic act.

## **MEDICALLY SPEAKING**

LEUKEMIA IS sometimes called "Cancer of the blood". In reality it is more than that. Leukemia is a fatal disease of the organs that make the blood, such as lymph glands, bone marrow, liver and the spleen. Normally, these organs make or produce only the normal number of red and white blood cells required for the normally healthy person. In Leukemia this formation or production gets out of control and there is tremendous over production of white cells. The white cells which are produced do not mature properly and are not able to fight infection the way they normally do. The number of red cells is reduced and so the patient becomes anemic. The blood does not clot properly, thus the afflicted patient may die from infection, hemorrhage or from damage to the vital organs. Leukemia is usually considered a disease of children but actually it affects more adults than children. Deaths from this disease have averaged between 10,000 and 14,000 per year in the last ten years.

#### The Causes of Leukemia

The exact causes of leukemia are still unknown. There is a growing suspicion that viruses play an important part in the development of this disease. Recent studies suggest that excessive radiation can produce leukemia. An increased number of cases of leukemia was found among those exposed to radioactive fallout from the atomic bomb blasts in Japan. More males than females get the disease. A leukemia epidemic, so called, occured in Niles, Illinois, a few years ago. A study of this group of children suggested that, while not infectious in the ordinary sense, the disease may have spread from some common source.

The symptoms of leukemia depend somewhat on the type, of which there are three: chronic, acute, and subacute. In the chronic case the symptoms come on rather gradually and are milder but

last longer. In the acute type the symptoms begin suddenly and progress rapidly. Subacute leukemia has some of the characteristics of both the chronic and the acute.


The chronic type usually occur in the middle age group and affects more men than women. As stated before, the symptoms come on slowly and it may be several years before significant changes occur. The spleen becomes enlarged and there may be sweating, skin eruptions, anemia, hemorrhages, nervousness, and loss of weight.

The acute type most often affects children. It begins suddenly, often with a sore throat, fever, and other symptoms of a cold. The glands in the neck, armpits, groins, spleen, and liver may rapidly enlarge. The child usually bruises easily, becomes pale, and complains of pains in the bones. Without treatment the child only lives a few weeks or months.

The positive diagnosis is made chiefly by a microscopic study of the blood and bone marrow.

The treatment, unfortunately at the present time, is very unsatisfactory. Constant research is being done on this subject and some day we hope the problem will be solved. At this time there is no cure. However, with modern drug therapy about twothirds of the cases can be slowed down and made more comfortable even for years. X-ray treatment and blood transfusions have been helpful toward this end. Replacement of the patient's diseased bone-marrow with healthy bone marrow offers some promise.

It is important to treat patients early. In order to do this, yearly examinations including a blood study should be performed regularly. The annual check is a good habit for you to have.



## **OUR PUBLIC SPEAKS**

CTA TRANSPORTATION employes are called upon to do many things in the line of duty besides just collect rider fares and issue transfers.

They are often required to placate customers who feel upset because of some occurrence for which the employe could not be held responsible. Again, they might be dealing with a person who is in a generally bad mood on that particular day, and expresses his feelings by taking it out on someone else.

However, by and large, CTA personnel in direct contact with the public do a commendable job and this is recognized by a vast percentage of riders whose favorable reactions, either verbally or written, bring comments like these:

"I would like to take this means of again commending one of your drivers (Wilbert L. Blakely, badge No. 689, North Park). Recently I was riding on bus number 8128 (Howard-Western) when the bus register broke. The driver tried his best to get it to work. When we arrived at Clark and Devon, he stepped off the bus momentarily to report it at a 'station.' A supervisor came aboard and pasted an 'out of order' sticker on the register. From then on, the driver was very patient in explaining to alighting passengers about the broken register and noted on a card every fare that he collected.

"What prompted me to write was his patience with some 50 students who boarded at Pratt and Greenleaf who evidently came from Sullivan High school. As usual some of the group made blunt remarks about him 'pocketing the money' and this driver did not lose his patience with them. He stamped every fare that he received on a card. His silence and patience with the whole group prompted me to write this."

Another letter from a pleased passenger follows:

"My thanks due to your employe, M. J. Frederick (Badge No. 6284, North Park) who was driving a Number 152 bus north on Michigan avenue on Saturday morning.

"In managing the packages I had in hand my pocketbook was pulled off my hand. Mr. Frederick found it and turned it in at the end of the line. I was notified that the wallet was there by mid-afternoon. I traveled to the terminal where I recovered the pocketbook with all contents intact. My experience has been that the bus drivers are exceptionally kind and helpful. But this service in recovering my valuable property was a high point."

This commendation citing Operator Robert L. Cavens, badge No. 2033, 77th, also was received:

"I am a very busy person as most of your customers are. I ride your buses a bit more than the average persons do daily, I think. During my trips I often meet an exceptionally fine bus driver. Tonight was an even greater exception to this rule.

"It was the Cottage Grove bus, southbound from Randolph and Wabash. The time was 9:30 p.m. After getting off the bus I took the time to get the license number so that this will aid you in commending the young man for his good service to the public. His patience with the senior citizens is something that I really noticed. Just being on his bus gave one a feeling of safety and not a I'll be glad to get off attitude. Please thank this young man for me for he is truly an ideal employe for the CTA."

As opposed to these fine testimonials, another letter is critical of the kind of personal service that irritates the public:

"Recently I was waiting, with other passengers, to board a bus at an "L"-surface transfer point. Before I had completely entered the bus the operator pulled away with the doors open and I barely had time to grasp the center post when the operator suddenly closed the door. When I called his attention to the incident, he became belligerent and said if I was not satisfied with the service I should use other transportation. I don't believe this type of behavior from an operator is tolerated by CTA. If the operator does not accept the fact that he has an obligation to the people he serves, he is in the wrong occupation."

COMMENT: Our employes have been trained to make certain that all passengers are safely aboard before closing their doors and setting their buses in motion. Employes who operate contrary to these instructions are subject to disciplinary action.
