## Pace

Pace has new leadership and a new mission: to shed its image as an operator of empty buses going nowhere. The suburban bus service is taking a new direction, looking to scale back its fixed-route system in favor of more flexible vanpooling and commuter services. Pace's new executive director and new board chairman are working on a plan to change the way the transit agency spends its \$114 million budget, a first step towards this: fundamental shift in service. While Pace will continue to run its most popular fixed routes, it is exploring ways to phase out less-traveled lines and devote more resources to its successful van-pool and special-event programs. In the next few years, Pace is expected to become more of a home-to-work commuter service and less of an all-day transit provider. (Crain's Chicago Business)

Pace's top administrator says that the suburban bus agency still needs a new headquarters. "My feeling is we have to be more accessible from the public transit viewpoint, said T. J. Ross. "Disabled riders have complained that it is tough getting to Pace's headquarters. We needed to be someplace where there were more buses, more Metra, more L, more something." That is why he looked around Rosemont, with its proximity to O'Hare Airport and CTA buses and trains, and towns such as Des Plaines and Melrose Park, where Pace has Garages, Ross Said. The search hasn't been fruitful. Land prices,



especially in Rosemont, and availability have been prohibitive. The current headquarters, which is over 35 years old, is inadequate and may have structural problems. (Chicago Sun Times)

## CTA

CTA Blue Line riders can now board/ alight from the newly reopened Grand/Milwaukee subway station. After being closed for about 7 years, CTA reopened it, improving the facilities by upgrading lighting, inserting automatic fare collection equipment and painting the place up. Also the station will have 24 four service, as compared to previous- no night, weekend service. This will make the commute to Navy Pier and the ever-expanding community around the station much more convenient.
