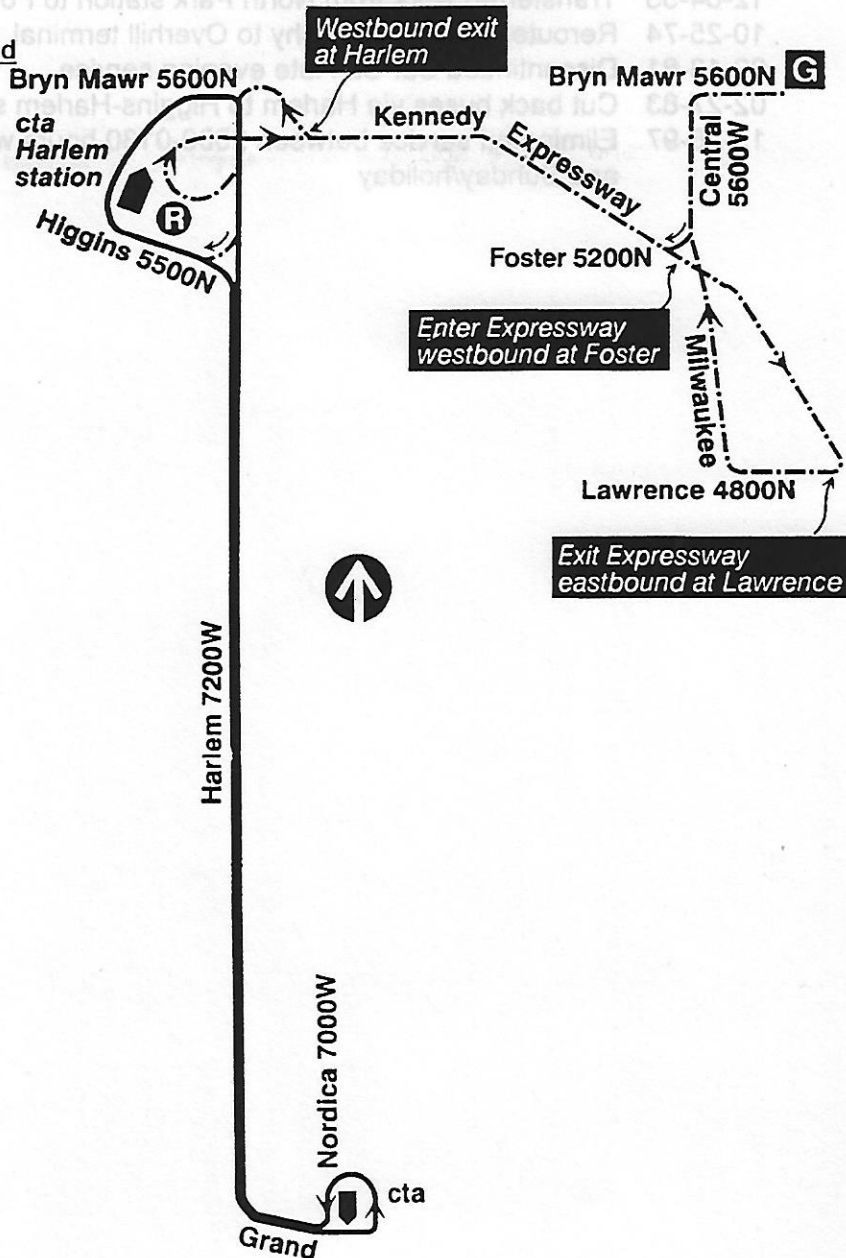

Harlem to Harlem-Farragut-Mont Clare-Berwyn loop
- 05-23-46 Extended buses from Farragut via Harlem-Foster to Foster-Ozanam-Farragut-  
Canfield loop
- 10-28-46 Rerouted buses via Harlem to Altgeld-Neva-Grand-Harlem loop
- 10-01-47 Route passes to CHICAGO TRANSIT AUTHORITY
- 04-01-51 Extended buses via Harlem-Grand to Grand-Sayre-Medill-Nordica loop
- 05-25-51 Rerouted buses via Grand to Nordica terminal
- 05-30-54 Transferred work from Lawrence station to North Park station
- 12-04-55 Transferred work from North Park station to Forest Glen station
- 10-25-74 Rerouted buses via Touhy to Overhill terminal
- 09-13-81 Discontinued Sat-Sun late evening service
- 02-27-83 Cut back buses via Harlem to Higgins-Harlem station terminal-Harlem loop
- 12-28-97 Eliminated service between 2300-0130 hours weekdays and 2100-2230 hours Saturday
