Route 561 Castlecrest via McAree

 Provides service between Washington/Genesee and Lewis/Edgewood in Waukegan. The Glen Flora Shopping Center is served by the route along with a mix of commercial and residential areas.

Route 562 Gurnee via Sunset

▲ Provides service between Washington/Genesee in Waukegan and Continental/Abington in Gurnee. Provides service to Gurnee Industrial Park. Continental Village, and Jack Benny Jr. High School.

Route 563 Great Lakes Naval Station

▲ Provides service between Washington/Genesee in Waukegan and Forrestal/Green Bay in the Great Lakes Training Center. Much of the Naval Center is served by the route as well as the V.A. Hospital, and the Factory. Also provides service to Abbott Labs, as well as the North Chicago and the Great Lakes Metra/UP-NW Stations.

Route 564 Jackson/14th
